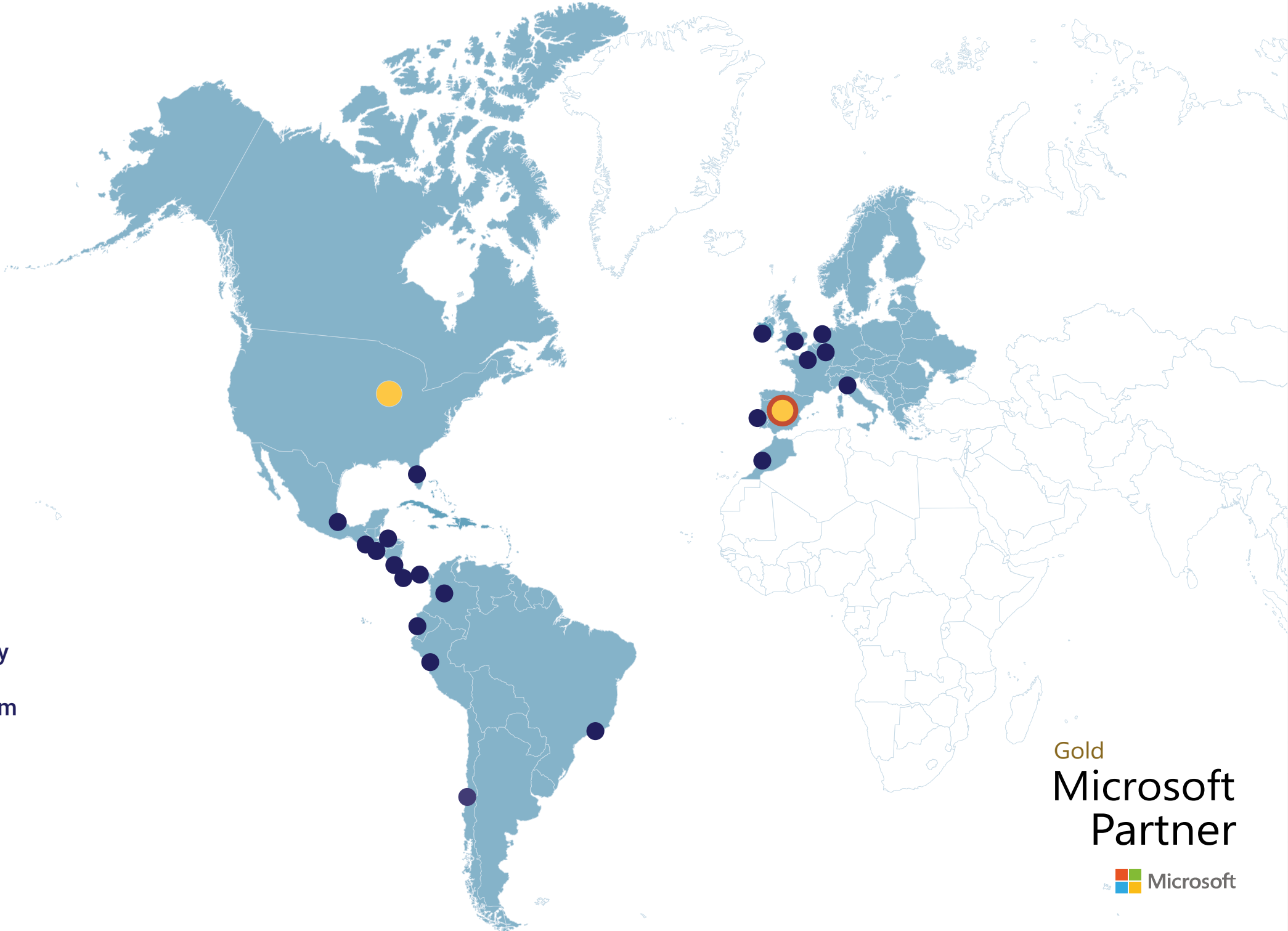

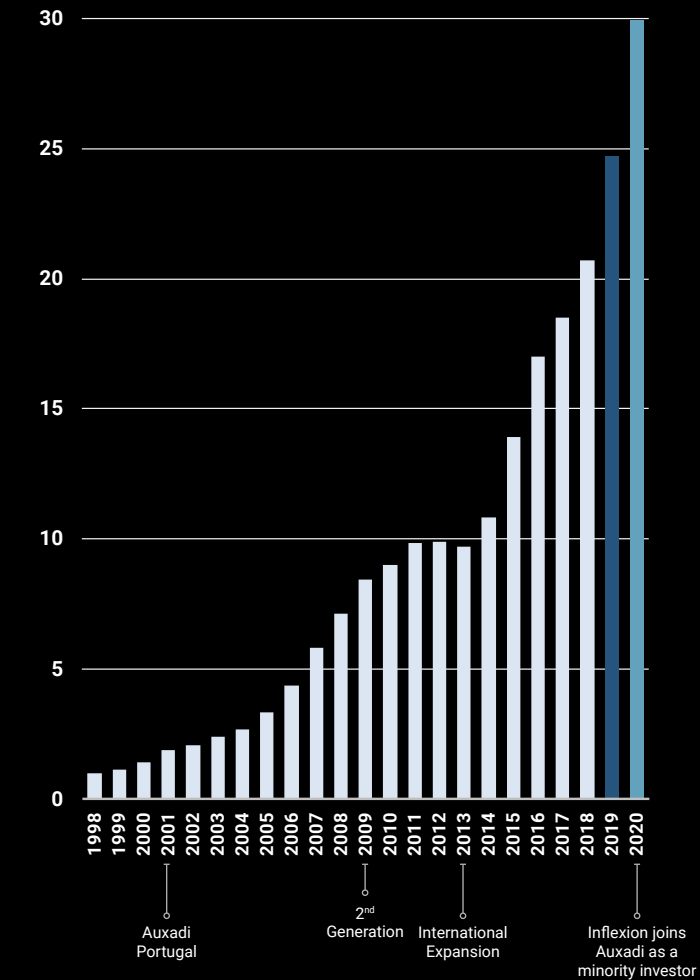

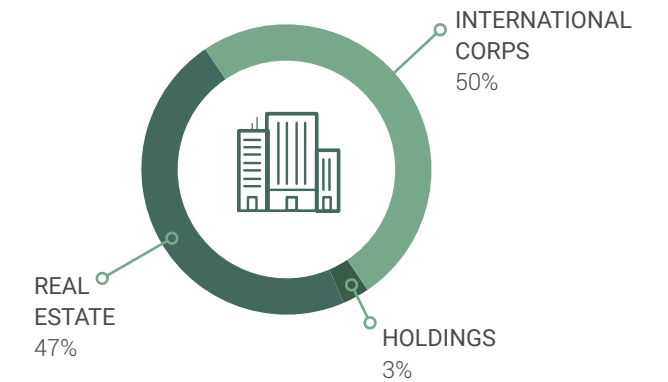


## Revenue trend (Millions of dollars)

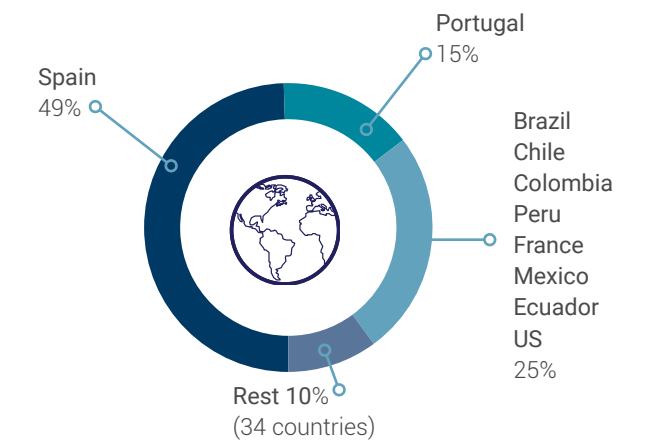

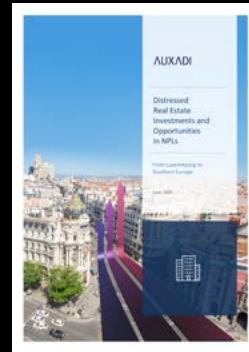

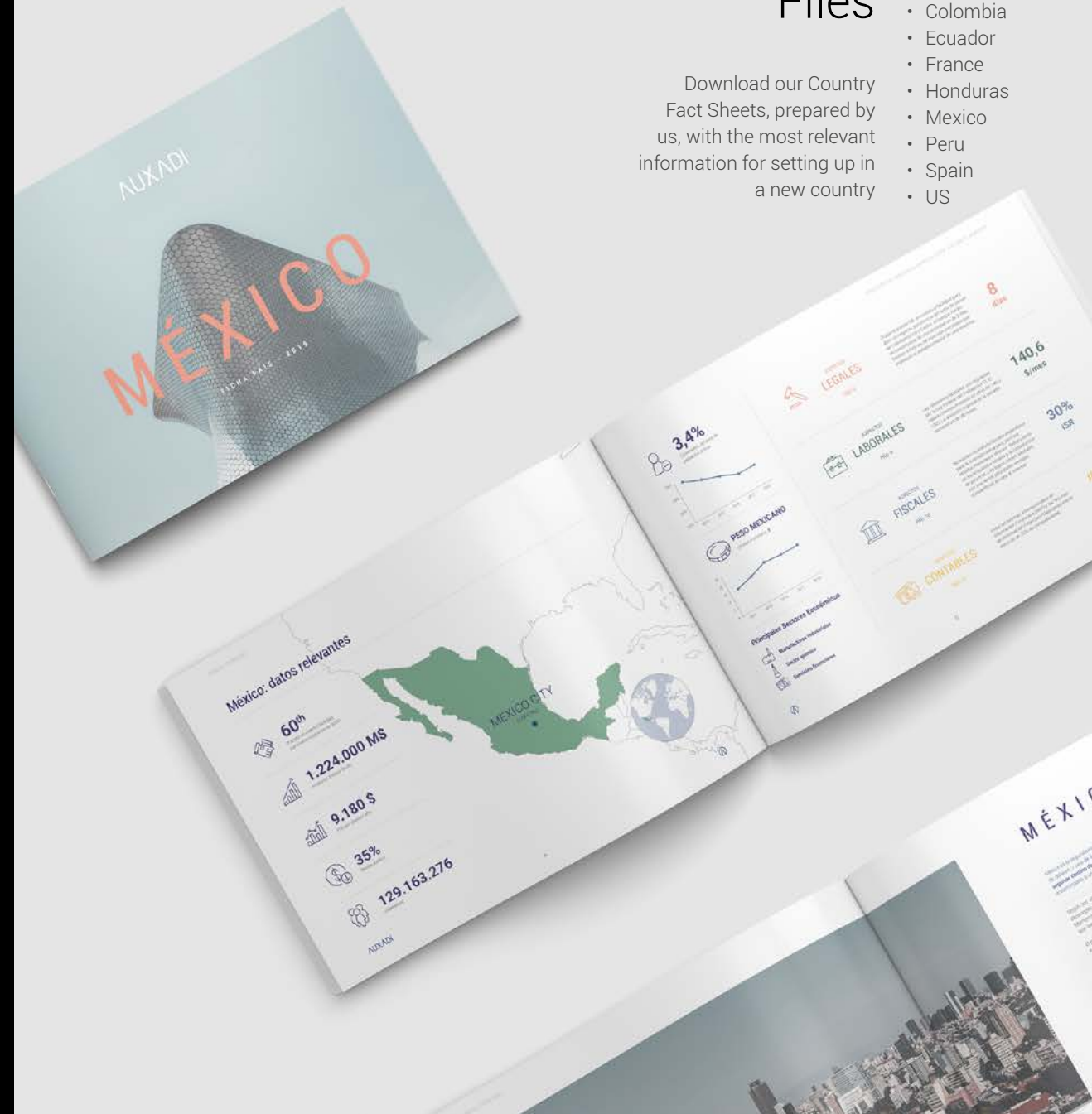
### Distressed Real Estate Investments and Opportunities in NPLs. From Luxembourg to Southern Europe

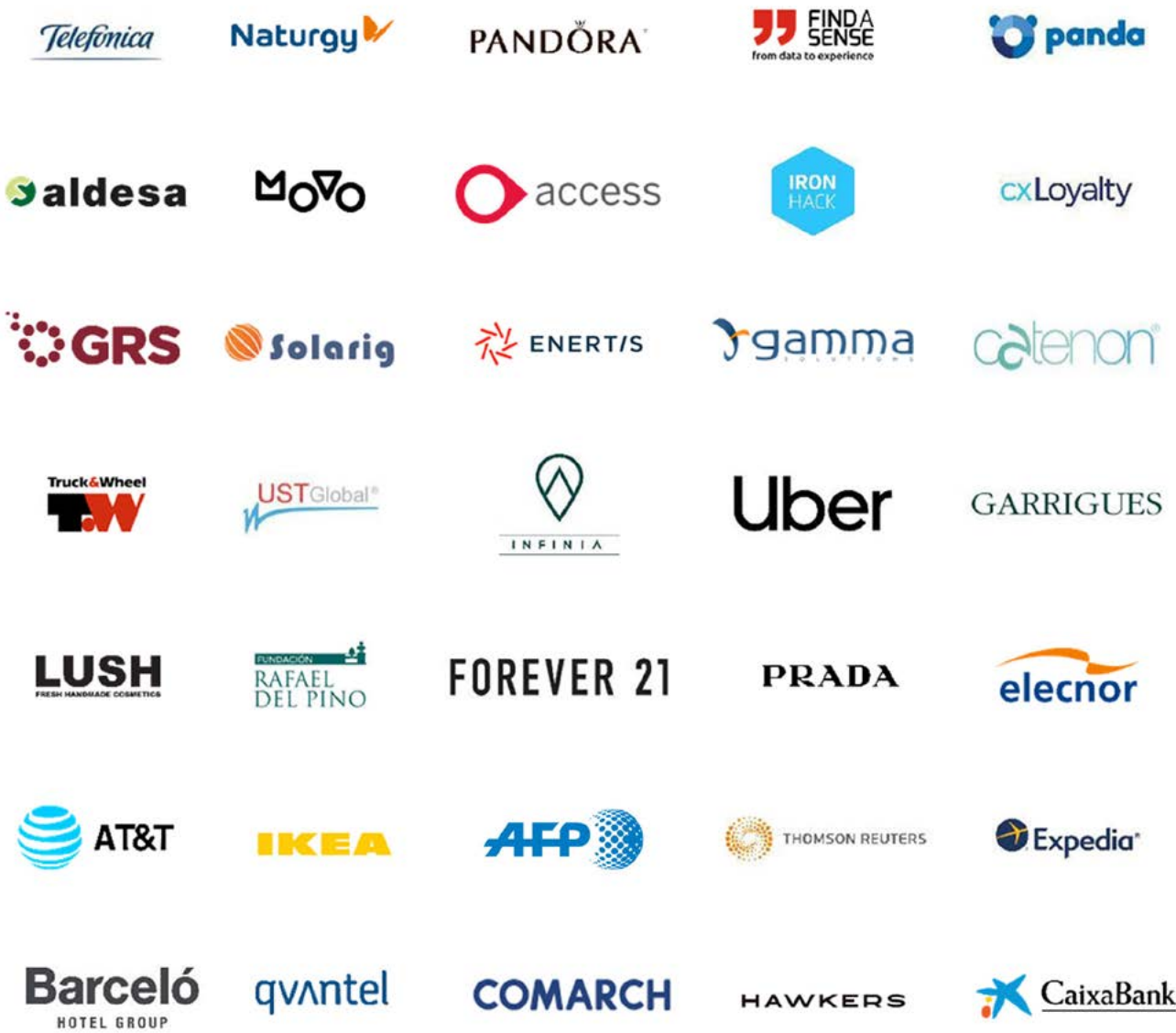
